

# Vuzix to Participate and Present at EWTS Boston, USA and AWE Europe Munich, Germany Industry Trade Shows

Lance Anderson, Vuzix VP of Enterprise Sales will be moderating a panel session during the AWE Europe event entitled, "Expanding Reality: Current and Future Smart Glasses Hardware and Use Cases Across Industries" alongside other industry leaders on October 19, 2017 at 2:00 PM Central European Time Zone (CET). As part of the panel Mr. Anderson will dive into the smart glasses market with a focus on hardware and use cases for that hardware, presenting thoughts and opinions from those directly involved. Discussion will include current trends and future expectations, accelerators and barriers, use cases, roadmaps, and more in relation to the smart glasses ecosystem.
